User manual for AGAMA wading pants

The company AGAMA was founded in 1991 and manufactures trilaminate and neoprene suits for diving, rescue services, and other water sports. AGAMA also provides service and repairs for all types of neoprene and membrane suits used in diving, rescue operations, and other water sports.

At the end of 2013, AGAMA shifted focus towards expanding its previously supplementary program for anglers. We actively develop and improve our wading gear and other accessories for fishermen. Our philosophy is to maintain the highest quality of manufacturing and service available in the Czech Republic!

The neoprene pants are made from high-quality neoprene material, which is coated with nylon fabric on both sides, with the inner side optionally lined with fleece. Among other advantages, this material is characterized by an exceptional degree of elasticity without losing any of its protective properties for the body. To ensure that the suit retains its properties, it must be properly maintained. With proper handling and care, the suit will last for many years of use, and the same applies to neoprene footwear.

MAIN MAINTENANCE PRINCIPLES FOR NEOPRENE SUITS OR FOOTWEAR:

- 1. For cleaning, use only soap (or shampoo specifically designed by the manufacturer for washing neoprene products) and clean water with a maximum temperature of 40°C.
- 2. After using the suit in chlorinated water, seawater, or otherwise contaminated water, rinse the suit (footwear) with clean water after use.
- 3. If sand or other dirt gets into the zipper, remove it with a soft brush.
- 4. After each use, allow the suit to dry thoroughly on both sides.
- 5. Dry and store the suit hung on a suitable hanger. NEVER DRY IT IN DIRECT SUNLIGHT OR NEAR HEATING SOURCES.
- 6. For minor mechanical damage to the suit, you can use the adhesive provided by us for repairs. For more significant damage, we recommend sending the suit to our repair service.



Composition 90% neoprene,10% nylon

INSTRUCTION FOR USE OF THE ADHESIVE:

- 1. Gently apply the adhesive to the degreased contact (bonding) surfaces of the neoprene.
- 2. After slight drying, press the surfaces together with gentle pressure.
- 3. Hand-stitch the damaged fabric with a cross stitch on both sides (do not sew through).

Warranty

The fishing trousers come with a 48-month warranty. The extended 48-month warranty covers the waterproofness of all seams and the quality of the material. The warranty does not cover wear and tear resulting from normal use (e.g., mechanical damage or wornout socks). The warranty guarantees that the suit, at the time of delivery and throughout the warranty period, will have all the properties of a properly functioning suit. The responsibility for defects occurring during the warranty period lies in the obligation to repair or replace the defective part with a new one, free of charge.

The warranty does not apply if the suit is:

- a) used in an environment not recommended in this manual,
- b) when the customer does not care for it as described in the manual,
- c) when the suit is mishandled, neglected, or damaged mechanically or chemically.

Any warranty claim during the warranty period must be made to the retailer without unnecessary delay after discovering the defect, along with the proof of purchase and this warranty certificate. After inspecting the suit and the purchase document, AGAMA will either repair or replace the suit if the claim is accepted.
